#### **ENTRY TERMS & CONDITIONS**

#### Please note:

Any entries not received by or on the closing date (midnight on the 14th May 2022) will not be allowed. Payment of entry fee plus the event package cost per person is a mandatory payment within 10 days of the entry deadline. Any entry and event package payments not received by this date will result in the entry being cancelled.

#### How to enter

Online entries can be made on the ESF Tournament Software website. The online entry system will open and accept entry and payment from March 2022 and will close at midnight on the 14th May 2022. Only entries endorsed by ESF member nations will be accepted. Late entries will be accepted only with approval by the CAP.

#### Closing date

The closing date for entries is midnight (UK time) on the 14th May 2022.

#### Payment of entry fee and event package

This must be paid upon entry by credit card payment.

- €15 ESF entry fee per person
- €175 event package per person



#### **European Squash ID (ESID)**

All players, coaches, managers and other officials must be registered with ESF. This must be approved and validated by the relevant MNF. The MNF is responsible for ensuring that all players, coaches, managers and other officials are registered with ESF prior to entry, and their entry is fully supported. Register for a ESID through the ESF tournament software website: esf.tournamentsoftware.com

#### **Withdrawals**

In the event of a withdrawal from the Championships, after the closing date, penalty fees additional to the entry fee will apply in accordance with Regulations Section V.

In the result of the event being cancelled due to the coronavirus pandemic and any restrictions in place within Scotland all entries will be refunded less any administrative fees incurred.

#### **EVENT PACKAGES**

Payment of entry fee plus the event package must be made by credit card when entering.

#### **Entry Fee**

ESF entry fee is €15 per person.

#### **Event Package**

The price of the event package is: €175 per person including the final party, but this does not include meals or accommodation.

#### **Hotel and Food**

Players are responsible for making their own arrangements and reservations for accommodation and meals.

#### **CHAMPIONSHIPS HOTEL(S)**

#### **TRANSPORT**

Transport will operate between all venues which everyone will be able to make use of

#### **ELIGIBILITY**

Player eligibility for the Championships is shown in Regulations - Section B2. Players must be aged over the set age on the first day of the competition (Thursday 22<sup>nd</sup> June 2022).

## **Categories:**

Men: 35+, 40+, 45+, 50+, 55+, 60+, 65+, 70+,75+, 80+

Women: 35+, 40+, 45+, 50+, 55+, 60+, 65+, 70+, 75+, 80+

Players are only allowed to enter one category.



#### **SEEDING AND DRAWS**

The seeding and draw will be carried out by the Seeding Panel under the direction of the Event Director and in accordance with Section V4 of the Championships Regulations. Member nations have no right of appeal against seeding or draws: Regulations - Section E.

#### **PRACTICE COURTS**

Practice facilities will be provided at no cost by the organiser and will be available at the venue starting the day before the Championships (Regulations – Section F6).

#### **REFEREES**

Qualified referees will be provided in accordance with ESF Referee Committee procedures relating to the specific Championships and Regulations - Section F9.

#### **SCORING**

PAR 11 scoring will be used (to 2 clear points).

#### **SQUASH BALLS**

The Dunlop PRO XX ball will be used.

#### **CHAMPIONSHIPS OFFICE**

The main Championship Office will be located within Edinburgh Sports Club. Further venue offices will be located in all other competition venues.

#### **RECORDING, PUBLISHING & LIVE STREAMING**

The recording of matches for coaching/performance analysis purposes is acceptable provided the player and/or their coaches do not object. The Championship will be publishing draws, results, photos of players as well as live streaming matches.

#### DOPE TESTING

The ESF and the hosts reserve the right to implement compulsory dope testing for any player participating in the Championships. Dope testing may be carried out in line with the doping regulations published by the WSF. Member nations are responsible for informing all their participants (including managers, coaches and physiotherapists) about the latest WSF policy on doping; and must impose the standard WSF suspension from all forms of competitive squash upon a player who has used banned substances or practices.

#### **INSURANCE AND RISKS**

Players enter and play in the Championships at their own risk. Neither the ESF, the Host Association, the Host Club nor the Organisers will accept any responsibility for injury or other damages arising from participation in the Championships. ESF and Scottish Squash recommends that all officials and participants have full travel, medical and possessions insurance when travelling to any Championships.



#### **CLOTHING AND ADVERTISING**

The ESF clothing and advertising regulations will be adhered to. In all matters of judgement or opinion arising from the interpretation of this clothing regulation, the decision of the Championships Referee shall be final (Regulations – Section P).

#### **VISA PROCEDURES**

Please note that visas may be required to enter Scotland. It is the responsibility of the member nation to ensure all players and officials have the appropriate documentation and that visas are applied for in good time before the Championships.
